01 -Categories of data we collect

We may collect personal data through your use of this App such as:

- ♦ email address.
- ♦ behavioral usage of the App.
- ♦ device identifiers (such as IDFA, IDFV for Android, GAID for IOS).
- ♦ the type and operator of network (such as Mac address).
- ♦ the type, version, brand, language and operating system of device.

02 -How we use your personal data

We use your personal data for the following purposes:

- ♦ To create & maintain a trusted environment for the App, including in order to manage the security of the App, networks, and systems operate, administer, analyze, develop, improve and optimize the use, function and performance of the App.
